

INSTRUCTIONS FOR USE

Spray: For optimum results hold bottle upright and spray from a distance of 6" to 8". Always close the nozzle after use.

Wetting: Apply solution with mop, disposable wiper, coarse spray device or by soaking so as to wet all surfaces thoroughly. Allow surfaces to remain wet for a minimum of 5 minutes and then either allow to air dry or if desired wipe dry with a (sterilized) cloth or wiper. See label for complete directions for use.
